### **JOB SUMMARY:**

Oversees injury response and management for troupers. Supports and maintains a positive atmosphere aligned with Smirkus Values.

### **ESSENTIAL FUNCTIONS:**

(Majority of duties, but not meant to be all-inclusive nor prevent other duties from being assigned as necessary.)

- Attend and monitor all circus performances, trainings, stagings, and rehearsals.
- Maintain regular communication with Medical Advisors regarding artist/athlete performance status.
- Maintain communication with Tour General Manager, Production Manager, coaches, and counselors regarding artist/athlete performance status.
- Provide evaluation and treatment services for 30 performers aged 10-18 years old in accordance with state Scope of Practice for certified Athletic Trainers in Vermont.
- Document all evaluation, treatment and pertinent artist/athlete interactions, in accordance with company policy, in provided medical record system.
- Communicate any supply needs to Tour General Manager.
- Develop and maintain effective communication with troupers, parents and staff members.
- Develop and administer Strength & Conditioning programs, when needed.
- Maintain professional relationships with all troupers, families, and staff.
- Maintain medical confidentiality.
- Educate troupers about body mechanics and awareness to keep them in performing shape.
- Participate in staff orientation and training sessions.
- Collaborate with touring coaches to create warm-up and strengthening routines.
- Communicate safety concerns to the Tour General Manager.
- Monitor troupers for changes in movement that could indicate the onset of injury.
- Assist in the set-up and tear down of back lot at the discretion of the Tour General Manager and Backlot Manager. Duties may include but not limited to: Setting and leveling bunkhouses, running hoses and electrical cords, setting up dishwashing station, setting up picnic tables and dining tent.
- Drive company vehicle.
- Other duties as assigned.

### **SAFETY & EMERGENCY PREPAREDNESS**

- Ensure compliance with Big Top Tour safety procedures for circus-related activities. Communicate and enforce safety standards.
- Ensure that coaching staff are trained on proper injury response plans.
- Collaborate with coaches, counselors, Tour General Manager, and other staff as appropriate, to respond to injuries and conduct rescue procedures.



• Respond to and manage Trouper injuries.

# **MINIMUM QUALIFICATIONS**

- Bachelor's degree from an accredited college or university.
- 2+ years field/practice experience in sports medicine.
- Current NATABOC Certification.
- Vermont licensed as Athletic Trainer or eligible.
- Current professional CPR/AED certification.
- Possess personal professional liability insurance.
- Able and willing to travel 100% of the time for length of contract.
- Able and willing to work non-traditional hours, including evenings, weekends and holidays.

- Master's degree in Athletic Training, Kinesiology, or health-related field.
- CSCS Certification through the NSCA.
- EMR certification through the American Red Cross.
- Experience working with performing artists/athletes (dancers, acrobats, aerialists, stunt performers, circus artists).
- Familiarity with a broad range of the circus arts.
- Thorough knowledge of best practices in safety and injury prevention in the circus environment.
- Demonstrated experience in working with children and teens in instructional settings.
- Ability to listen, communicate, and respond to multiple constituencies, to solve problems, and to create "win-win" situations with people of all ages.
- Ability to relate to and motivate both troupers and staff.
- Ability to work collaboratively in a team.
- Ability to interact with trouper parents as an ambassador of Circus Smirkus.

#### **WORKING CONDITIONS:**

- Internal: Work is normally conducted in an office environment.
- External: Work requires travel throughout Vermont and surrounding states in preparation for and while on summer tour.
